Rector's Report (included pg. 3) - There is discussion on having another Pumpkin Patch in October. It was decided that a committee be gathered within the month to see if it is viable and to see if there is way to make it easier on the volunteers.

It was decided that Calvary will hire CMS Solutions to help Calvary apply for the Employee Retention Tax Credit.

Since Christian is stepping down as treasurer, a motion to nominate Scott McLemore as the new treasurer was made by Fred and seconded by Bob. The motion passed.

Fr. Ralph will go over Vestry duties and appointments at the February $14^{\text {th }}$ meeting.

Bob gave a report on the progress of the Capital Campaign. The office of the Capital Campaign committee is being organized. The theme and scripture have been decided. The theme is Celebrating the Legacy, Building for the Future. The scripture is Hebrews 3:4. The cost of the project is $\$ 2.5$ million. Some of the money will come from grants and outside gifts along with pledges from the congregation. The architect will give a presentation to the parish on January $15^{\text {th }}$ between services. Beginning in February there will be small group meetings in parishioner's homes for questions and more in-depth discussion of the project.

It was suggested that the foundation repair committee create a recommendation for the vestry to vote on that includes the target goal, the plan and timeline of the project. This will be done before the contract is signed.

A motion was made by Susan to remove Christian Iversen from the b1BANK check signing card for the general operating and money market accounts and to add Scott McLemore as a check signer to the general operating and money market accounts. The motion was seconded by Bob. The motion passed.

The meeting was adjourned at 8:18p.m. Rick gave the closing prayer.
